- (iii) Those who desire to submit fee, IA-I form and registration form electronically are required to follow the steps as detailed below.
 - a. Download challan form of Intermediate (Pre-Agri.) from University website www.uaf.edu.pk. After completing the same, **deposit fee at home town in any Branch of MCB or HBL through online TBD account and avoid carrying cash to Campus for safety reasons.**
 - b. Download courses enlistment form (IA-I) of Intermediate (Pre-Agri.) 1st Semester as well as University Registration form (E2) and complete the same in all respects.
- (iv) The fee challan, IA-I form, University Registration form (E-2) complete in all respects and missing documents (as indicated against their names in the list), if any, be submitted by hand or sent through any means as a pre-requisite for completion of admission / enrolment formalities. These documents should reach in Office of the undersigned **not later than 8.9.2015, otherwise admission shall be treated as cancelled without assigning any reason and they shall have no claim whatsoever.**
- (v) Hard copies of fee challan, IA-I and registration form (E-2) are also available in Office of the undersigned.
- (vi) The following documents will be provided by each admitted candidate within fifteen days from issuance of this notification.
 - a. Declaration and undertaking on separate judicial papers worth Rs. 200/- each as per specimen displayed on the Notice Boards and included in the brochure.
 - b. Submission of medical fitness certificate issued by the medical officer of a Government Hospital, MBBS Practitioner (Registered with PMDC) or Medical Officer(s) of University.
- (vii) Those who have been indicated **as overage** in remarks column, should contact office of the undersigned immediately for submission of proper request for onward consideration by the competent authority. They are not allowed to submit dues until the age relaxation is granted by competent authority.

- (viii) The candidates who have submitted detail marks/result intimation of matric alongwith admission application form, should produce four attested copies of prescribed certificate immediately on receipt from the Board. In case any student fails to provide copies of requisite certificate, he/she shall be restrained to continue further studies/cancel his/her admission.
- (ix) In case any information/document attached with the application form is found as Bogus/Tempered/Fabricated etc. at any stage of studies, the admission shall be cancelled retrospectively without assigning any reason.
- (x) Errors and omission accepted.

Note the fee should be deposit in home town banks.
